Airsoft Arena Acknowledgement of Risk, Release & Waiver

- I acknowledge that entering and using the Arena at Riverside CQC (the "Arena") carry risks. Plastic projectiles and other objects can cause serious injuries. Serious injuries may also occur during games or other activities my family or guests or I may participate in or observe, including injuries, which may result from the action, inaction or negligence of others.
- I knowingly and voluntarily assume these and all other risks. I understand that Riverside CQC does not maintain health medical or disability insurance for my benefit or the benefit of my family and that I will be responsible for the cost of any medical services incurred by or for us unless I obtain my own insurance.
- In consideration for the right to use the ARENA, I and on behalf of, as applicable, my minor children, heirs, personal representatives and assigns, (a) release The Arena at Riverside CQC, and all of its parent and affiliate entities; the City of Riverside, the County of Riverside; and the officers, members, directors, contractors, employees, elected officials, umpires, referees, sponsors, advertisers, volunteers and agents of any of the foregoing (Collectively the "Released Parties") from or with respect to any and all liability, from any cause whatsoever (including without limitation, negligence in rendering, or not rendering, medical or emergency aid), for any loss of life, bodily injury, property damage and / or other loss I or my minor children may suffer or incur in, about or en route to or from the ARENA and (b) waive any and all rights I or they may have to make a claim against Barracks CQB Arena at Riverside CQC, or to sue any Release Party for any such loss of life, injury, damage or other loss.
- I acknowledge and agree to abide by all rules and regulations established by the Arena at Riverside CQC. I understand that I may be suspended from the Arena at Riverside CQC for dangerous, violent, abusive, offensive, and disruptive or other comparable conduct and agree to indemnify the Release Parties from the consequences of any such conduct, including attorneys' fees and costs.
- I acknowledge the Arena at Riverside CQC is not responsible for theft, lost items, property damage or vandalism. I consent to the use of my image and likeness in the Arena at Riverside CQC advertising and promotional materials without compensation. I authorize representatives of the Arena at Riverside CQC to obtain emergency treatment for my minor children, or myself in the event of illness or injury.
- I agree that any action brought by me, or anyone on behalf of my minor children, against any of the Released Parties or me shall be subject to binding arbitration conducted under the rules of the American Arbitration Association in the county in which the Arena at Riverside CQC is located. If any provision hereof is found to be invalid or unenforceable, such determination shall not invalidate or render unenforceable any other provision.
